Special Called Meeting

March 3, 2014

Minutes

5:30 pm

Mayor Burke called the Special Called meeting of the Morrow City Council to order at 5:30 pm. The meeting took place in the Council Chambers of the Morrow Municipal Complex, 1500 Morrow Road, Morrow, Georgia 30260.

Interim City Clerk Sylvia Redic called the roll and those present were Mayor JB Burke, Councilmember Jeanell Bridges, Mayor Pro Tem Hang Tran, Councilmember Larry Ferguson, and Councilmember Christopher Mills; The City Clerk stated there was a quorum present.

Mayor Burke asked everyone to stand for the Pledge of Allegiance followed by a moment of silence.

2. APPROVAL OF MEETING AGENDA:

MOTION AND VOTE: Councilmember Bridges motioned to amend the agenda by putting the SPLOST agenda item as number one under New Business and the City Manager Contract as item two. Councilmember Ferguson seconded the motion. Councilmembers Ferguson and Bridges voted in favor of the Meeting Agenda Amendments. Mayor Pro Tem Tran and Councilmember Mills voted in opposition. Mayor Burke broke the tie and voted in opposition. The motion to amend the agenda did not pass.

MOTION AND VOTE: Mayor Pro Tem Tran made a motion to approve the meeting agenda, seconded by Councilmember Mills. Councilmembers Bridges and Ferguson voted in opposition. The Mayor broke the tie and voted to approve the Meeting Agenda and the motion carries.

3. NEW BUSINESS:

1. Approval of the Contract for the City Manager.

MOTION AND VOTE: Councilmember Mills motioned to approve the contract for City Manager Ron Few, Councilmember Tran seconded. Councilwoman Bridges abstained and Councilman Ferguson voted in opposition. The abstention is counted as an affirmative vote and the motion carries.

2. Approval of SPLOST Contribution to Clayton County to assist Southern Regional

MOTION AND VOTE: Mayor Pro Tem Tran made a motion to approve \$150,000 annual contribution from SPLOST for a period of six years only if the seven cities of Clayton County also contributed at least 50% of the amounts suggested and outlined on the Proposed IGA, Voluntary %, with Tier 2 Projects, 6 year collection spread sheet. Councilmember Mills seconded, the motion passed unanimously.


5. **ADJOURNMENT:**
