Mayor JB Burke asked everyone to stand for the Pledge of Allegiance followed by a moment of silence.

1. ROLL CALL:

Mayor JB Burke asked City Clerk to call the roll.

City Clerk Viet Tran called the roll and those present were: Mayor JB Burke, Councilwoman Jeanell Bridges, Councilman Larry Ferguson, and Councilman Christopher Mills. Mayor Pro Tem Hang Tran was absent. The City Clerk stated, there was a quorum present.

MOTION AND VOTE: Councilman Larry Ferguson made a motion to approve an ordinance to amend the title 8, Subdivision regulations with the amendment, to strike and remove the last two (2) sentences of paragraph (a) of Section 8-6-3; and to add: This requirement shall also apply to combine two (2) or more lots. Councilwoman Jeanell Bridges seconded the motion. The motion passed unanimously.
