- Ordinance No. 2015-11 Place of Assembly

AN ORDINANCE TO AMEND THE OFFICIAL ZONING CODE OF THE CITY OF MORROW, GEORGIA, AS AMENDED; TO PROVIDE FOR THE REGULATION OF LAND USE RELATING TO PLACES OF ASSEMBLY, CHURCHES AND OTHER PLACES OF WORSHIP; TO PROVIDE NEW DEFINITIONS IN THE ZONING CODE; TO PROVIDE FOR SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Code Enforcement Marti Tracy stated the Zoning Ordinance change presented for your consideration is intended to enhance the economic potential of our limited commercial areas as well as provide sufficient opportunity for new places of assembly to establish within the City of Morrow.

The new Ordinance proposed that:

Churches, synagogues and other places of assembly become permitted uses in the Public Institutional Zoning Districts and Conditional Uses in all other zoning. The Ordinance change does not impact currently operating places of assembly but will more closely regulate the location of those proposed in the future.

As a conditional use, the Mayor and Council would have the opportunity to decide whether the establishment of place of assembly would be the best use for the location in question. The Mayor and Council would determine if the use would prove beneficial to the city, if the place of assembly would contribute to the economic health of the city and consider other matters that may arise in the conditional use process.

Obviously, our commercial districts are our most valuable economic asset. Approval of proposed Ordinance provides for responsible growth management within city's commercial districts and will help secure the commercial appeal of our shopping areas as they contribute to the economic development and financial needs of the city.
