**The new Flood MAP will be released upon completion and it will change location and size of floodway.**

**FEMA must give the city permission to cross the floodway.  
FEMA will define how high and how long the bridge must be.  
Once the above is known a conceptual estimate on cost to engineer and build the bridge will be performed. This information will be provided in a future work session.  
Additional submittal fees for LOMR and C-LOMR may be required by FEMA approximately \$15,000**
