

**CITY OF MORROW, GEORGIA**  
**MINUTES OF REGULAR MEETING**  
**December 14, 2010 – 7:30 pm**

**Mayor Pro Tem Bob Huie** called the regular meeting of the Morrow City Council to order at 7:30 pm. The meeting took place in the Council Chambers of the Morrow Municipal Complex, 1500 Morrow Road, Morrow, GA, 30260.

**City Clerk Evyonne Browning** called the roll and those present were Councilman John Lampl, Councilman Virlyn Slaton, Councilman C.R. Huie, and Councilman Mason Barfield. Mayor Jim Millirons was absent.

**Mayor Pro Tem Bob Huie** asked everyone to stand for the Pledge of Allegiance followed by a moment of silent reflection.

**APPROVAL OF MEETING AGENDA**

**City Clerk Evyonne Browning** stated there were no changes to the meeting agenda.

**Mayor Pro Tem Bob Huie** called for a motion and vote to approve the Meeting Agenda.

**MOTION AND VOTE:** Councilman John Lampl moved to approve the Meeting Agenda. Councilman Mason Barfield seconded the motion. The motion passed unanimously.

**City Clerk Evyonne Browning** read the following Consent Agenda items:

## **FIRST PRESENTATION:**

**City Clerk Evyonne Browning** read the following First Presentation Item:

1. Agenda Item 10-12-206, Approval of an Ordinance of the City of Morrow, Georgia to provide for Procedures for Conduct of Hearings pursuant to Section 5.16 of the City Charter; To designate a Hearing Body; To specify due process requirements; to prescribe time frames; and for other purposes.

## **OLD BUSINESS:**

**City Clerk Evyonne Browning** read the following Old Business item:

1. Agenda Item 10-12-207, Approval of an Ordinance Amending the Code of Ordinances of the City of Morrow, Georgia; To Revise the Standards for Outdoor Watering of Landscape; to repeal conflicting provisions; and for other purposes.

**City Manager Jeff Eady** presented the item and said this ordinance is being required by the State to control outdoor watering from 4:00 pm to 10:00 am.

**Mayor Pro Tem Bob Huie** called for a motion and second.

**MOTION AND SECOND:** Councilman Mason Barfield moved to approve Agenda Item 10-12-206. Councilman John Lampl seconded the motion.

**Mayor Pro Tem Bob Huie** asked if there were any comments. Hearing none, he called for a vote.

**City Clerk Evyonne Browning** read the following New Business item:

1. Agenda Item 10-12-208, Approval of a Resolution Authorizing the City of Morrow to prepare and present an Application for Community Development Block Grant Funds from Clayton County Housing and Community Development Program and in accordance therewith accept Grant Funds for the Community Development Block Grant (CDBG) Entitlement Program – FY 2011; This Resolution authorizes the Mayor or his designee to execute the Application and City Staff to otherwise perform all acts necessary to accomplish the intent of this Resolution; To provide an effective Date; and for other purposes.

**City Manager Jeff Eady** presented the item and stated this grant will provide up to \$300,000 in funds with no match to the City and gives the staff the authority to move forward in the process.

**Mayor Pro Tem Bob Huie** called for a motion and second.

**MOTION AND SECOND:** Councilman Virlyn Slaton moved to approve Agenda Item 10-12-207. Councilman Mason Barfield seconded the motion.

**Mayor Pro Tem Bob Huie** asked if there were any comments. Hearing none, he called for a vote.

**VOTE:** The motion passed unanimously.

**Mayor Pro Tem Bob Huie** made the call to citizens for comments. There were none.

**Mayor Pro Tem Bob Huie** asked if the City Manager had any comments.

**City Manager Jeff Eady** wished everyone a Merry Christmas.


