

**CITY OF MORROW, GEORGIA
MINUTES OF REGULAR MEETING
May 28, 2013 – 7:30 pm**


Mayor Burke and Mayor Pro Tem Larry Ferguson both stated they concur with all that Councilwoman Bridges said.
