This item is final plat review and approval of a single lot division at property address 7057 Mt. Zion Circle, Morrow, GA 30260 also known as LA Fitness. The applicant, Sharon Chapman of U.S. Properties, requests to subdivide the LA Fitness property from an existing larger lot, known as Southlake Pavilion shopping center. The subject property is zoned General Business (GB).

Mayor JB Burke called for a motion to adjourn the September 29, 2014 Special Called Meeting.


MOTION AND VOTE: Councilman Larry Ferguson made a motion, seconded by Mayor Pro Tem Hang Tran. The motion passed unanimously.
